

### **GIFTS of GRAIN**

Thank you for feeding the world through your harvest and hard work.

Will you consider making a gift of grain to feed our rural community?

#### WHAT IS A GIFT OF GRAIN?

If you produce a marketable commodity, you can gift it to Cornerstone Community Wellness, a registered 501(c)3 nonprofit, who will work with local elevators to receive and sell the commodity. Gifts of grain received in the Fall of 2022 will be designated toward Cornerstone's *rural grocery project or general fund at your preference*.

#### WHY SHOULD I MAKE A GIFT OF GRAIN?

#### **Tax Savings**

By donating grain to a charitable organization, the farmer can exclude the sale of the grain from gross income, which can result in a triple tax savings (federal, state, and self-employment).

#### **Expenses Related to Production**

Expenses related to the production of donated grain are deductible. A donation of grain reduces reportable income.

#### **HOW IT WORKS**

#### Inform Cornerstone of your gift intention

#### Deliver grain to elevator



Request transfer of pledged bushels to Cornerstone.

Cornerstone coordinates sale and distribution of funds with elevator.

# You receive acknowledgement letter



Request receipt of acknowledgement to from elevator to farmer for purpose of maintaining production records.

#### **CONSIDERATIONS**

- To make a gift of grain, you must be a cash basis farm operator. Landlords using a crop share rental agreement are not eligible to donate.
- Grain is gifted to Cornerstone prior to the sale, so no prior sale commitments can exist on the commodity.
- Donors of grain should not report this as a charitable donation. There is no additional deduction allowed since the tax benefit comes from the deduction of production expenses and exclusion from income.
- · Keep documentation from the elevator to maintain yield history.
